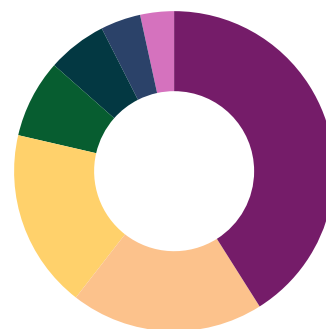
Strategy Objective

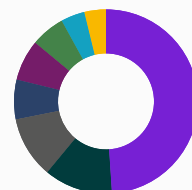
