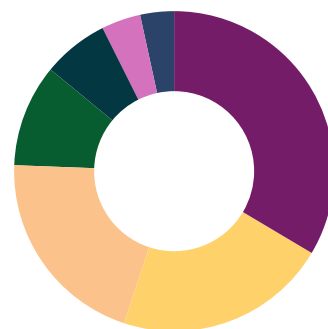
Strategy Objective

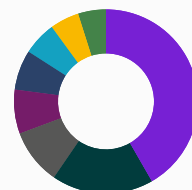
