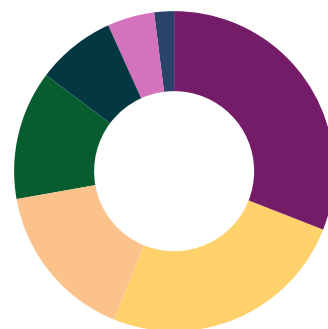
Strategy Objective

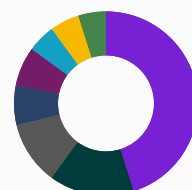
