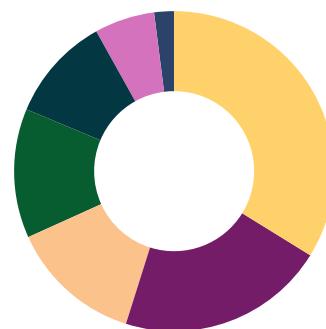
Strategy Objective

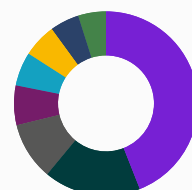
