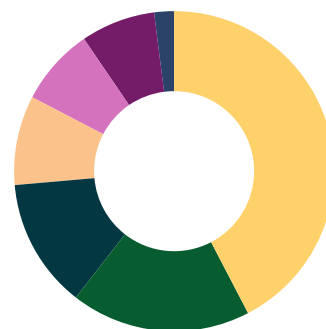
Strategy Objective
