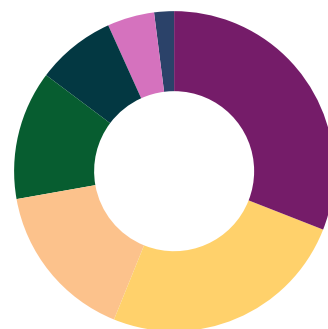
Strategy Objective

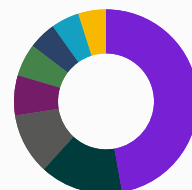
